

MA IN LAW (TAUGHT IN BULGARIAN)

Brief presentation of the program:

The program complies with state requirements for acquiring higher education in "Law" and combines theoretical and practical courses in the areas of public and private law. Educational training for the program is for five years and includes a mandatory six-month internship period and state examination covering theoretical and practical aspects of the subject.

During the first and second year of study alongside the basic auditorium courses and extracurricular classes, the program covers general requirements for knowledge and skills in Bulgarian language, computers, sports, arts, foreign language.

Throughout the education there are basic and essential courses covering the general theory of law, history of law, constitutional law, administrative law enforcement, Roman private law, comparative constitutional law, civil law, administrative law and administrative process, administrative justice, the legal regime of the cadaster, property law, financial law, family law, hereditary law, contractual law, tax law, international legal protection of intellectual property, commercial law, international public law, procedural tax law, employment law, criminal law, social security law, civil procedural law, law of the European Union, criminology, and exercises in each of the courses.

There are also optional lecture courses, including general theory of the state, legal sociology, basic philosophy of law, law-making, parliamentary law, police law, copyright, legal framework of marketing and advertising, legal regulations of electronic media, legal protection of competition, medical law, refugee law, international treaties, maritime commercial law, and judicial expertise.

Extracurricular learning modes include independent course works in all major law fields, internship municipality, court and the prosecution.

The program courses are in full compliance with the Ordinance on Unified State Requirements for acquiring higher educational degree "Law" and qualification "Lawyer."
